A SEPARATE LICENSE MUST BE OBTAINED BY A LICENSED PEDDLER FOR EVERY AGENT OR EMPLOYEE WORKING FOR HIM. ALL LICENSEES SHALL BE REQUIRED TO CARRY THE LICENSE WITH HIM/HER AT ALL TIMES. HE/SHE MUST PRODUCE LICENSE UPON REQUEST OF ANY OFFICIAL OF THE BOROUGH OF NORTHVALE</i>			
ANY PERSON WHO VIOLATES THE PROVISIONS OF NORTHVALE BOROUGH CODE CHAPTER 140 SHALL BE PUNISHABLE AS PROVIDED IN CHAPTER 1, ARTICLE 1, GENERAL PENALTIES.			
A license may be revoked by the Mayor and Council by reason of the violation of the terms of the license, the violation of any municipal ordinance or state or federal statute or falsification in applying for a license. The licensed person must be granted a hearing by the Council upon his request. A license may be suspended for not more than two weeks by the issuing officer without a hearing.
