WHEREAS, such resolution of certification shall be adopted by the governing body no later than forty-five days after the receipt of the annual audit, as per the regulations of the Local Finance Board; and

WHEREAS, all members of the governing body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board; and

WHEREAS, failure to comply with the promulgations of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of R.S. 52:27BB-52 - to wit:

R.S. 52:27BB-52 - "A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office."

**ORDINANCE# 963-2016 - CAPITAL ORDINANCE PROVIDING FOR CONVERSION OF GARBAGE TRUCK IN AND FOR THE BOROUGH OF NORTHVALE, COUNTY OF BERGEN, STATE OF NEW JERSEY; APPROPRIATING \$90,000.00, THEREFORE FROM THE CAPITAL FUND SURPLUS TO PAY FOR THE COSTS THEREOF**

WHEREAS, the Borough of Northvale, in the County of Bergen, State of New Jersey (the “Borough”), wishes to undertake the Conversion of a Garbage Truck and other related expenses; and

WHEREAS, the cost of said improvements is estimated to be \$90,000.00; and

WHEREAS, the Borough desires to authorize the appropriation and expenditure of \$90,000.00 from the Capital Fund Surplus in the same amount, to undertake said improvements and purchases.

BE IT ORDAINED AND ENACTED BY THE BOROUGH COUNCIL OF THE BOROUGH OF NORTHVALE, COUNTY OF BERGEN, STATE OF NEW JERSEY, AS FOLLOWS:

SECTION 1. The Capital Improvement of the Conversion of a Garbage Truck is hereby authorized as a general capital improvement to be undertaken by the Borough. There is hereby appropriated the amount of \$90,000.00 for said improvement or purpose.

SECTION 2. The sum of \$90,000.00 is hereby provided from Capital Fund Surplus and appropriated for the purposes in Section 1 of this Ordinance.

SECTION 3. Said improvements are lawful capital improvements of the Borough having a period of usefulness of at least five (5) years. Said improvement shall be made as a general improvement, no part of which shall be assessed against a property specifically benefitted.

SECTION 4. No Supplemental Debt Statement is required, since this ordinance does not authorize the issuance of any debt.

SECTION 5. The Capital Budget of the Borough is hereby amended to conform with the provisions of this capital ordinance to the extent of any inconsistency herewith and a resolution in the form promulgated by the Local Finance Board showing full detail

of the amended capital budget and capital programs as approved by the Director of the Division of Local Government Services, New Jersey, Department of Community Affairs is on file in the Office of the Borough Clerk and is available for public inspection.
