CALL THE MEETING TO ORDER -

Resolution Authorizing Cancellation of Unexpended Balances in the Amount of \$59,074.74 from the Current Fund Budget for Calendar Year 2012

WHEREAS, it is necessary to officially cancel such balances so funds can be transferred to Surplus at year-end, and anticipated as Revenue item in the following year budget; and

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Northvale, County of Bergen, New Jersey, that unexpended balances in the amount of \$59,074.74, listed below, be cancelled and lapsed to Surplus.

ROLL CALL VOTE: Councilman Marana, Councilman Sokoloski, Councilwoman Libby, Councilman Piehler, Councilman Shepard and Councilman Sotiropoulos voted yes.

Motion by Councilman Sotiropoulos; seconded by Councilman Shepard to approve Resolution #2012-157, as follows:

RESOLUTION #2012-157

Authorize the Appropriation of Funds to Negotiate Settlement with Belmont Construction – 176 Paris Avenue – "The Manor"

WHEREAS, the Borough has been made aware of a claim by the contractor who built the Manor at Northvale age restricted, affordable housing project at 176 Paris Avenue within the Borough namely, Belmont Construction, 240 West Passaic Street, Suite 11, Maywood, New Jersey 07607, for permit fees paid in connection with the said project in the amount of Seventeen Thousand Five Hundred Seven Dollars; and

WHEREAS, the claimant, Belmont, has allege that pursuant to statute, to wit, NJSA 52:27D-126e, permit fees should have been deemed waived by the Borough due to the nature and extent of the Affordable Housing Project constructed; and

WHEREAS, the statute aforementioned is not clear as to whether the project is applicable to the section calling for permit fees to be waived, and it is in the fiscal interest of the Borough to settle all claims without further action, whether by administrative action, mediation, arbitration, litigation or other official means; and

WHEREAS, the Borough wishes now to avail itself of a negotiated settlement agreed to in principal by and between Belmont and the Borough, without any admission of liability or wrongdoing, in order to take advantage of finality and avoid costs of litigation; and

WHEREAS, it appears, as evidenced by the Chief Financial Officers Certification that funds are available in the Borough Capital Budget, Building Department Account or such other account as may be appropriate, in that amount for the purpose of resolving the stated claim.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the Borough of Northvale, that the sum of Eight Thousand Seven Hundred Fifty Three and 50/100 (\$8,753.50) Dollars be and is hereby appropriated to resolve any and all issues with Belmont Construction set forth herein and same shall be paid over to Belmont Construction, c/o Carmine R. Alampi, Esq., Alampi & Demarrais, One University Plaza, Hackensack, NJ 07601 forthwith; and

BE IT FURTHER RESOLVED that the Mayor and Borough Clerk by and are hereby authorized to execute any documents that may be required to conclude the matter

by and between the Borough and Belmont to effectuate the intent and purpose of this Resolution.

ROLL CALL VOTE: Councilman <u>Sotiropoulos</u>, Councilman Shepard, Councilwoman Libby and Councilman Marana voted yes. Councilman Piehler and Councilman Sokoloski abstained.
