

#### M I N U T E S Special Meeting of the Mayor and Council Tuesday, June 25, 2024 7:00 PM

Mayor McGuire called the meeting to order at 7:00 PM in the Council Chambers at 116 Paris Avenue, Northvale, New Jersey 07647.

# Mayor McGuire read the Open Public Meetings Act Notice into the record as follows:

"This is a Special Meeting of the Mayor and Council of the Borough of Northvale. The date, time and location of this meeting have been advertised in the official Newspapers of the Borough, filed with the Municipal Clerk, and posted on the bulletin board in the Municipal Building. #### Mayor McGuire suspended the regular order of business for the public hearing of the 2024 Budget. Mayor McGuire opened the meeting to the public for questions on the 2024 Amendment to the Municipal Budget.

**Kenneth Cho, 423 Wildwood Road** – under parks & playgrounds there is an additional \$18,000 listed in salaries & wages. Mr. Luppino explained there is a trust account for parks. Salaries are usually charged to the trust account. Since we are using \$30,000 for capital this year for the dugouts at Hogan Park from the trust account, we listed the additional amount under salaries & wages. Mr. Luppino further explained that in the Senior Center budget, salaries are charged to the trust account. The money in the trust account is from donations and this money is dwindling down. Next budget we will properly classify them. Mr. Cho said it is a bookkeeping issue. Mr. Luppino stated the recreation trust will always be fine.

Mr. Cho also asked under the appropriations from 2023 it shows add on budget appropriations based on New Jersey statute, does this happen every year or just this year? It is on page 3A of the budget. Mr. Luppino answered that when the budget was adopted subsequent grants came which are under Chapter 159. This does not affect the tax levy. He continued, the state's fiscal year is different than ours. If the grants are issued after July, we have to amend our budget. Councilman Sokoloski added that they are different every year since we do not know what grants we will receive.

There being no one else from the public, Mayor McGuire closed the meeting to the public.
